GUARANTY

The undersigned Guarantor(s), each individually and jointly and severally, in order to induce Graphic Solutions Group, Inc. and its affiliates, subsidiaries, trade name entities, and business units (collectively "GSG" or "Graphic Solutions") to extend credit and/or sell equipment, products and/or services to Customer, do(es) hereby irrevocably and unconditionally personally guarantee, individually and jointly and severally, all sums which may be owed by Customer to GSG, whether said indebtedness is due now or hereafter incurred, without deduction for any claim of offset or other defense. Further, the undersigned Guarantor(s) irrevocably and unconditionally guarantee due and punctual performance and observance by Customer of all other terms, covenants, and conditions of Customer's Application for Credit, GSG's Sales Terms and Conditions, and any Sales Contract, Sales Contract and Security Agreement, or other written agreement between GSG and Customer, whether according to the present terms thereof, at any earlier or accelerated date or dates as provided therein, or pursuant to any extension of time or to any change or changes in the terms, covenants, or conditions thereof now or hereafter made or granted.

Guarantor(s) hereby agree that this Guaranty may be enforced by GSG against Guarantor(s) without first resorting to or exhausting any other security or collateral and without first having recourse against Customer. Guarantor(s) further agrees that the obligations of Guarantor(s) hereunder are independent of the obligations of Customer or any other Guarantor. This shall be a continuing guaranty and shall not be revocable, except upon actual receipt by GSG of written notice sent via certified mail, return receipt requested, that the undersigned, or any of them, revoke said Guaranty as to transactions subsequent to the date of such notice is received at Graphic Solutions Group, Inc., Attention: President, 4601 Spring Valley, Dallas, Texas, 75244 and, in such event, the Guarantor(s), individually and jointly and severally, shall continue to be responsible for any and all transactions which occurred prior to the date GSG actually received said notice.
